
On August 8, 2011, the Public Service Commission accepted Cannonsburg Water District's, ("Cannonsburg") application for approval of emergency rate relief to adjust its rates for water service for the purpose of addressing non-revenue water reduction efforts. Subsequently, the Public Service Commission entered and Order On August 7, 2014 addressing Cannonsburg's Unaccounted-For Loss Reduction Plan, Surcharge and Monitoring Plan. While the Order the addressed several key issues regarding the plan, it failed to grant Cannonsburg the authority to make payments of its costs associated with the implementation of its Unaccounted-For Loss Reduction Plan, Surcharge and Monitoring.

Specifically, the Order failed to mention and authorize Cannonsburg to pay the engineering costs in the total amount of \$12,632.00 Invoices attached hereto and marked as Exhibits "A".

Engineering services play a necessary and vital role to the implementation of Cannonsburg's non-revenue water reduction efforts. Success in the plan can only be achieved by the engagement of such engineering professional services. The costs of the engineering services submitted are fair and reasonable.

WHEREFORE, the applicant Cannonsburg Water District, formally requests an Order Amending and or Modifying the Order entered August 7, 2014 authorizing Cannonsburg Water District to pay certain engineering costs associated with the Unaccounted - For Water Loss Reduction Plan, Surcharge and Monitoring and further requests the authorization of payment of legal fees in the amount of \$800.00 for having brought this motion.


