

Americatel has registered additional fictitious names, AMETEX and 1 800 3030 123 Americatel Collect, which it intends to begin using in Kentucky. Americatel will continue to do business in Kentucky under the fictitious names 10 123 Americatel and 1010 123 Americatel. Americatel, however, will also do business under the fictitious names, AMETEX and 1 800 3030 123 Americatel Collect. The use of these additional fictitious names is only a name change, and does not involve any change in majority organizational control or other change in ownership. Please acknowledge the use of the additional fictitious names, AMETEX and 1 800 3030 123 Americatel Collect for Americatel and advise whether another revised tariff is required to add the additional fictitious names or if we may provide you with labels to be placed in the heading section on each page.
