

5. Gabriel does not seek to provide operator-assisted services to traffic aggregators as defined in Administrative Case No. 330.

Also included with this cover letter and supporting documentation is Gabriel's Kentucky General Exchange Tariff, which includes local and long distance services, and Gabriel's Kentucky Access Tariff. The tariffs both bear an effective date of April 20, 2000, which is thirty days from the date of this filing.
