Names of the Parties to the Transactions. The parties to the transaction are PNG Telecommunications, Inc. d/b/a PowerNet Global Communications ("PNG") who will acquire subscribers from GlobalTouch Telecom, Inc. ("Global Touch").

Types of Telecommunications Services Provided to Affected Customers. GlobalTouch provides resold, switched long distance and intraLATA toll services to the affected customers. PNG will provide the same services on the same terms, rates and conditions.

Date of the Transfer. The parties anticipate that the affected customers will be transferred to PNG on or after March 14, 2008.

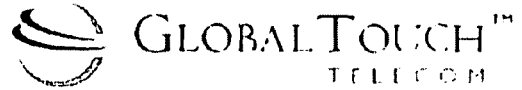
