On behalf of Golden Harbor of Kentucky, Inc. ("Golden Harbor" or the "Company"), enclosed for filing are an original and four (4) copies of this letter of intent, as well as Golden Harbor's proposed long distance and local exchange tariffs. In accordance with the Commission's Orders in Administrative Case No. 359 (dated June 12, 1996), Administrative Case No. 355 (dated September 26, 1996) and Administrative Case No. 370 (dated January 8, 1998), Golden Harbor submits the following information:

4. Golden Harbor has not provided nor collected for telecommunications service in Kentucky prior to filing this notice of intent. Please see notarized statement attached hereto at Exhibit B.
5. Golden Harbor does not seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330.
6. Golden Harbor plans to provide all forms of telecommunications services throughout the Commonwealth of Kentucky, including both intrastate local exchange and interexchange telecommunications services. This will be accomplished through a combination of Golden Harbor's own facilities and through the resale of the facilities of other certificated carriers. Golden Harbor therefore seeks authority to offer its services to business and residential customers as both a facilities-based carrier and a reseller of telecommunications services. Golden Harbor's services will be available on a full-time basis, 24-hours a day, seven days a week. Golden Harbor intends to begin service as soon as possible, depending upon regulatory approval and the execution of applicable interconnection agreements.
