Dear Mr. Dorman:

eMeritus Communications, Inc. ("eMeritus" or "the Company") respectfully submits an original and one (1) copy of this letter to notify and request approval from Kentucky Public Service Commission ("Commission") of the Company's name change to VarTec Solutions, Inc. ("VarTec Solutions"). A copy of the Amended Certificate of Authority to Transact Business in the Commonwealth of Kentucky is attached hereto as Exhibit A for your records and reference.


eMeritus has been certified to provide interexchange telecommunications services within Kentucky since August 30, 1995 on which date the Commission granted approval in Docket Number 95-246 of the Company's Certificate of Public Convenience and Necessity. eMeritus was also granted authority to provide local exchange services in Kentucky on June 19, 1996 (Docket No. 96-233); however, the Company is not currently operating as a local exchange provider.

The Company has determined that the name change from eMeritus Communications, Inc. to VarTec Solutions, Inc. will further develop the Company's ongoing business plan while allowing greater recognition and cohesion with the Company's parent, VarTec Telecom, Inc., and the VarTec family of companies. The aforementioned name change will not in any way inconvenience or cause harm to the Company's customers, and Kentucky businesses will continue to be provided high quality, affordable telecommunications services by the Company under the name VarTec Solutions, Inc.

Pursuant to Commission rules and regulations, eMeritus has included as Exhibit B a revised copy of the Company's Kentucky Tariff Number 4 reflecting the new corporate name. Please note that the Company name and issuer authority and address has been modified. eMeritus will begin notifying customers of the new corporate name via bill insert on September 1, 2004 and has included a copy of the bill insert as required by the Commission. The Company believes that prior Commission approval of this name change is not required, and as such, will begin conducting business within the Commonwealth of Kentucky under the name VarTec Solutions, Inc. effective immediately.


