O R D E R

On March 25, 1965, the Commission issued its Order in Case No. 4378 approving certain rates and providing, under certain conditions, for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On January 14, 1982, Elzie Neeley Gas Company, Inc., ("Elzie Neeley") notified the Commission that its wholesale cost of gas would be increased by one of its suppliers, Columbia Gas of Kentucky, Inc., ("Columbia") effective January 1, 1982, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission. The notice set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to increase the cost of natural gas of its supplier.

The amount of the increased cost of gas to Elzie Neeley will be \$5,978 on an annual basis.

After reviewing this evidence of record and being fully advised, the Commission is of the opinion and finds that:

(1) Elzie Neeley's supplier has filed increased rates and said rates will become effective on and after January 1, 1982.

(2) Elzie Neeley's notice of January 14, 1982, failed to provide the 20 days notice as required by statute and, therefore, the rates should become effective for service rendered on and after February 3, 1982.

(3) Elzie Neeley's adjustment in rates under the purchased gas adjustment approved by the Commission in its Order in Case No. 4378 dated March 25, 1965, is fair, just and reasonable and in the public interest and should be allowed to be effective with gas supplied on and after February 3, 1982.

IT IS THEREFORE ORDERED that the rates including the proposed purchased gas adjustment be and are hereby approved to be effective with gas supplied on and after February 3, 1982, as set out in Appendix A, attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Elzie Neeley, the base rate for purchased gas shall be:


