O R D E R

On May 25, 1990, Western Rockcastle Water Association ("Western Rockcastle") filed an application with the Commission for authority to increase its 5/8 x 3/4 inch meter tap-on fee from \$300 to \$350 and to charge actual cost of installation for all other meter sizes. Western Rockcastle also proposed to establish a Service Reconnection Charge of \$30, a Meter Reading Recheck Charge of \$15, a Requested Meter Test Charge of \$20, an Inspection of New Service Line Charge of \$25, a Returned Check Charge of \$10, and a customer deposit equal to 2/12 of the estimated annual bill.

On June 8, 1990, the Commission issued a letter requesting that certain filing deficiencies be cured within 15 days. On June 21, 1990, Western Rockcastle requested an extension of time to file the information. The Commission, by Order dated June 28, 1990, granted an extension of time until July 9, 1990. On July 6, 1990, Western Rockcastle filed the requested information.

Western Rockcastle has filed schedules with the Commission which itemize the expenses involved in providing the above-mentioned services. After reviewing the evidence and being

sufficiently advised, the Commission finds that the proposed charges are equal to the expenses incurred to provide the associated services. It further finds that the proposed charges as set forth in Appendix A to this Order are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The charges listed in Appendix A to this Order, which is attached hereto and incorporated herein, are approved for services rendered by Western Rockcastle on and after the date of this Order.


2. Within 30 days from the date of this Order, Western Rockcastle shall file its revised tariff sheets setting out the charges approved herein.

The following rates and charges are prescribed for the customers in the area served by Western Rockcastle Water Association. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

All Other Size Meters	Actual Cost
Service Reconnect Charge	\$30
Meter Reading Recheck Charge	\$15
Request Meter Test	\$20
Inspection of New Service Line	\$25
Returned Check Charge	\$10
Deposit - 2/12 of estimated annual bill
