O R D E R

On October 10, 1990, in Case No. 90-002 the Commission approved certain adjusted rates for East Kentucky Utilities, Inc. ("East Kentucky") and provided for their further adjustment when the wholesale cost of gas changes or a refund is received.

On August 13, 1997, East Kentucky notified the Commission that its wholesale cost of gas will be decreased by its supplier effective November 1, 1997, and submitted with its notice information required by its purchased gas adjustment ("PGA") clause.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. East Kentucky's notice proposed revised rates designed to pass on its wholesale decrease in gas cost in the amount of 32.71 cents per Mcf.
2. East Kentucky's contract with Equitable Resources Marketing Company ("EREC") contains a pricing provision which decreases East Kentucky's cost of gas from \$3.00 per Dth to \$2.75 per Dth effective November 1, 1997.
3. East Kentucky's adjustment in rates is fair, just, and reasonable, in the public interest, and should be effective for gas supplied on and after November 1, 1997.


IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are approved effective for gas supplied on and after November 1, 1997.


2. Within 30 days of the date of this Order, East Kentucky shall file with this Commission its revised tariffs setting out the rates authorized herein.


