



**LOGAN TELEPHONE COOPERATIVE, INC.'S NOTICE
OF EXEMPTION FROM MANDATORY POOLING REQUIREMENTS**

Logan Telephone Cooperative, Inc. ("Logan"), an independent rural telephone cooperative, by counsel and pursuant to the June 15, 2007 order ("Order") of the Public Service Commission of the Commonwealth of Kentucky (the "Commission"), hereby notifies the Commission of the following exemptions from mandatory number pooling.

<u>Rate Center (NPA NXX)</u>	<u>Basis for Exemption</u>
Adairville (270 539)	Logan is the only carrier receiving numbering resources, and it has not received a request for the provision of local number portability ("LNP"), in this rate center.
Auburn (270 542)	Logan is, at this time, the only carrier receiving numbering resources in this rate center, although one carrier recently requested that LNP be implemented in this rate center.
Dunmor (270 657)	Logan is the only carrier receiving numbering resources, and it has not received a request for the provision of LNP, in this rate center.
Lewisburg (270 755)	Logan is, at this time, the only carrier receiving numbering resources in this rate center, although one carrier recently requested that LNP be implemented in this rate center.
Logansport (270 728)	Logan is the only carrier receiving numbering resources, and it has not received a request for the provision of LNP, in this rate center.
Rochester (270 934)	Logan is the only carrier receiving numbering resources, and it has not received a request for the provision of LNP, in this rate center.


