

COMMISSION STAFF'S FIRST INFORMATION REQUEST
TO FARMDALE DEVELOPMENT CORPORATION

Farmdale Development Corporation ("Farmdale") is requested, pursuant to 807 KAR 5:001, to file with the Commission no later than 14 days from the date of this request, the original and 5 copies of the following information, with a copy to all parties of record. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

1. At page 4 of its Amended Application, Farmdale estimates that it will cost \$225,215 to make various repairs and replacements to its sewer utility plant. For each item proposed to be repaired or replaced, describe the repair or replacement that

will be performed, and provide bids or estimates from 3 nonaffiliated sources to support each of Farmdale's cost estimates.
