**MOTION FOR EXTENSION OF TIME AND  
FOR THE RESCHEDULING OF INFORMAL TECHNICAL CONFERENCE**

Kentucky Utilities Company ("KU") hereby moves the Kentucky Public Service Commission ("Commission") for an extension of time through and until June 12, 2006 in which to file responses to Appendix B of the Commission's April 25, 2006 Order and also to reschedule the informal technical conference in this matter to June 20, 2006.

As grounds for this Motion, KU states that the request for information contained in Appendix B of the Commission's April 25, 2006 Order is extensive and requires the collection of sensitive information from multiple sources. The information also must be reviewed by multiple employees from a number of different departments to ensure the accuracy of the responses. KU seeks to reschedule the informal technical conference in this matter in order to allow the Commission sufficient time to review such responses. This Motion for Extension of Time and for the Rescheduling of Informal Technical Conference is not made for the purpose of unduly delaying the Commission's examination and if granted will not prejudice the Commission's ability to conduct its examination.

**WHEREFORE**, Kentucky Utilities Company respectfully requests that the Commission issue an order by Friday, June 2, 2006 granting an extension of time through and until June 12, 2006 to file responses to Appendix B of the Commission's April 25, 2006 Order and rescheduling the informal technical conference to June 20, 2006.
