A telephonic informal conference was held on August 22, 2006 to discuss procedural matters concerning the September 6, 2006 hearing. The following individuals were present for the conference:

On August 11, 2006, the Commission issued Orders scheduling the public hearings in these cases for September 6, 2006. The telephonic informal conference was held to determine if the parties believed public hearings were needed.

After a brief discussion, the parties agreed that public hearings would not need to be held and the parties would submit simultaneous comments by September 28, 2006. KU and LG&E indicated they would draft a joint motion to be submitted by the parties requesting that the September 6, 2006 hearing be cancelled and the case be submitted on the record after the filing of comments.

The conference was then adjourned.
