O R D E R

On September 13, 2006, the Commission issued an Order establishing a procedural schedule in this case. The procedural schedule required, among other things, that direct testimony be filed by all parties on or before October 4, 2006. On September 27, 2006, Kentucky Utilities Company ("KU") moved the Commission to amend the procedural schedule to allow an additional two days for the filing of direct testimony. In support of its motion, KU states that its primary witness has been out of town since September 21, 2006 and will not return until October 2, 2006 and that its counsel will be out of town on October 4, 2006. KU further states that the extension should apply to all parties and that no other changes to the procedural schedule should be required as a result of this request. KU states that Cumberland Valley Electric, Inc. has no objections to the motion.

Having considered the motion and finding that the existing procedural schedule should be revised as requested, the Commission HEREBY ORDERS that:


1. KU's motion for an extension of the filing deadline for direct testimony is granted.

2. The procedural schedule set forth in the Commission's Order of September 13, 2006 is amended to allow direct testimony by all parties to be filed no later than October 6, 2006.

3. All other provisions of the Commission's procedural schedule of September 13, 2006 shall remain in full force and effect.
