


**JOINT MOTION FOR
EXTENSION OF TIME**

SouthEast Telephone Inc. ("SouthEast") and BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") jointly move the Commission for an extension of thirty (30) additional days, until July 1, 2008, in which they must file their final interconnection agreement in this case. As grounds for their motion, SouthEast and AT&T state that although they are diligently negotiating final terms and conditions in accordance with the Commission's Orders, the complexity of some of these issues makes it unlikely that negotiations can be completed, and the final document signed, by June 2, 2008, the date set by the Commission in its Order of May 2.


