ORDER

On August 31, 2006, Northern Kentucky Water District ("NKWD") applied to the Commission for approval of its Depreciation Report. The Commission entered an Order on October 30, 2006 establishing a procedural schedule to be followed in this proceeding. NKWD moved for an extension of time to file its response to the requests of Commission Staff contained in Appendix B of the October 30, 2006 Order, which was granted. On November 15, 2006, NKWD filed its response to the requests of Staff contained in Appendix B.

The Commission finds that the procedural schedule issued on October 30, 2006 should be suspended so that an informal conference might be scheduled for the purpose of discussing the adequacy and responsiveness of NKWD's answers to Staff's requests.

IT IS THEREFORE ORDERED that:


1. The procedural schedule issued on October 30, 2006 is suspended until further Order of the Commission.

2. Commission Staff shall schedule an informal conference for the purpose of discussing the adequacy and responsiveness of NKWD's answers to the requests contained in Appendix B of the October 30, 2006 Order.
