ORDER


The city of Wilmore, Kentucky ("Wilmore") has moved for a continuance of the scheduled informal conference in this matter and for additional time in which to respond to the Commission's Order of September 22, 2006. In support of its motion, Wilmore states that it is in negotiations with Jessamine-South Elkhorn Water District regarding the proposed charge that is the subject of this proceeding and the Wilmore City Council will very shortly consider some of the proposals arising from these negotiations. The Commission finds that the requested continuance may permit the parties to resolve some of the issues that gave rise to this proceeding and should therefore be granted.

IT IS THEREFORE ORDERED that:

1. Wilmore's Motion for Continuance and Additional Time is granted.
2. The informal conference that is scheduled for October 31, 2006 is continued generally.
3. Wilmore shall have until December 11, 2006 to respond to the Commission's Order of September 22, 2006.
