On December 19, 2007, the Commission issued an Order in this proceeding authorizing a \$1,905,793 increase in revenues and approving new rates included in Appendix A to that Order. Upon further review, the Commission finds that the rates approved for Schedule 2, Commercial Rate, contained an error.


IT IS THEREFORE ORDERED, to be entered nunc pro tunc, that:

1. Appendix A to our December 19, 2007 Order is amended to reflect a Schedule 2, Commercial Rate customer charge of \$14.87 and an energy charge of \$0.06469.
2. All provisions of the December 19, 2007 Order that are not in conflict with the terms of this Order shall remain in effect.
