O R D E R

On December 18, 2006, the Commission established the 2-year fuel adjustment clause ("FAC") review cases for American Electric Power Company ("AEP"), Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E"). The Commission adopted the procedural schedule set forth in Appendix A of these Orders. Kentucky Industrial Utility Customers, Inc. ("KIUC") has been granted intervenor status in the AEP, KU and LG&E cases.

In its January 24, 2007 letter, KIUC served notice that it intends to file testimony in the AEP, KU and LG&E FAC review cases and requested that the Commission allow intervenor testimony to be filed in those cases 14 days after filing of the responses to interrogatories and data requests. On February 1, 2007, KU and LG&E filed motions to modify the procedural schedule to afford the opportunity to issue data requests concerning, and rebuttal testimony to, the testimony that KIUC has stated it will file in

this proceeding. The Commission's February 14, 2007 Order granted the motions of KIUC, KU and LG&E to extend the procedural schedule and set forth the modified procedural schedule requested by KU and LG&E. To facilitate the processing of the three cases, the procedural schedule of AEP was also changed to mirror the KU and LG&E procedural schedules.

On March 2, 2007, KIUC requested, due to the complexity of the issues involved in the proceedings, that the procedural schedule for the KU and LG&E FAC review cases be further amended to allow the parties additional time to review case documents. KIUC stated in its request that all parties have agreed to the amended procedural schedule suggested in its motion.

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that KIUC's request to extend the procedural schedule for the KU and LG&E FAC review cases is reasonable, for a proper purpose and should be approved. Further, the Commission finds that in order to promote the efficient processing of the cases before it that the procedural schedule for the AEP FAC review in Case No. 2006-00507 should be similarly extended according to the same schedule.

IT IS THEREFORE ORDERED that:

1. KIUC's motions to extend the procedural schedules in Case No. 2006-00509 and Case No. 2006-00510 are granted.
2. The procedural schedule in Case No. 2006-00507 is modified to conform to the procedural schedule set forth in Appendix A.
3. The revised procedural schedule set forth in Appendix A supersedes any schedule previously established and shall be followed in these proceedings.

4. AEP, KU and LG&E shall notify their customers in writing of the date, time, place, and purpose of the hearing or shall publish such notice in accordance with Administrative Regulation 807 KAR 5:011, Section 8(5). Proof of publication shall be filed prior to the day of the hearing.
