MOTION FOR EXPEDITED HEARING AND STANDARD PRE-HEARING ORDER


Comes Cellco Partnership, a Delaware General Partnership, d/b/a Verizon Wireless (hereinafter referred to as "Applicant"), by counsel, and moves the Kentucky Public Service Commission ("PSC") to schedule an early public hearing in the within administrative action, and, so as to facilitate the orderly consideration of issues in this action and to incorporate the PSC's standard provisions and restrictions as part of its pre-hearing compliance schedule and hearing procedure, including, but not limited to:

- a. The Applicant requests that the PSC's standard pre-hearing compliance schedule include a requirement that all proposed alternative sites must be identified and submitted by Intervenor within fifteen (15) days in order to be considered at the hearing in this action. No Intervenor or any person subsequently granted intervention may submit evidence regarding alternative sites for the proposed facility at the hearing in this matter, except in regard to those specific sites, if any, for which information is filed within fifteen (15) days.

- b. The Applicant requests that the PSC's standard pre-hearing compliance schedule include a requirement that Applicant file a response as to the availability and technical feasibility of utilizing any of the timely-submitted potential alternative sites within forty-five (45) days.
- c. The Applicant requests that the PSC's standard pre-hearing compliance schedule include a limitation on evidence that will be considered by the PSC in this action. Specifically, evidence pertaining to the effects Radio Frequency Emissions or Radio Frequency Interference, as consideration of such matters is preempted by federal law; (See Southwestern Bell Wireless, Inc. v. Johnson County Board of County Commissioners, 199 F.3d 1185 (10th Cir. 1999)), and is prohibited or not relevant under the Telecommunications Act of 1996. 47U.S.C. §332(7)(B)(iv). (See also: Paragraph 5 of PSC Order of December 21, 2000 in Case No. 2000-071UAC.)

WHEREFORE, the Applicant, by counsel, urges the PSC to schedule an early public hearing in the within administrative action, and to incorporate the above-referenced provisions and restrictions as part of its pre-hearing compliance schedule.
