

Pursuant to 807 KAR 5:063 Section 1(1)(q), notice is given that ALTEL Communications, Inc. is seeking a Certificate of Public Convenience and Necessity from the Public Service Commission of Kentucky to construct a cellular communications tower at 14305 Old U.S. Route 23, on the dividing ridge between New U.S. 23 and Old U.S. 23 north of Savage Branch, in Boyd County, Kentucky. The tower coordinates are N 38°20'49.950" Latitude and W 82°36'9.510" Longitude. With appurtenances, the tower will be 189 feet above ground level.
