We received a letter from you today about a cell phone tower being erected near the business and property that we own. I (Pam writing) understand the need for cell phones and their towers and most particularly in low income areas. I am in favor of anything PROACTIVE that will increase the economic level of this area of the US. I know that they are being used effectively in other low income areas in the world to build the economies reportedly because they are much cheaper to install than land lines. I am also very much in favor of having high speed internet over electric lines since most properties do have electricity and with the rise in cell phone use, we may face deterioration of phone lines. That being said, I have some questions.

The business on our property, Tri-County Veterinary Clinic, uses wireless technology for the computers in the office. We also use cordless phones. How will the cell phone tower transmissions affect them? IF the tower emissions will cause a problem with our networks, can something be done to alter the transmissions so that does not happen? We have spent money and time developing this network and do not want it to develop unnecessary problems or be rendered incapable of operating.

Ten years ago I was associated with a sustainable scientist who had been contacted by some people in Australia to "fix" the problems that cell phones and other devices related to that technology cause to plants and animals which includes the human animal. I connected Governor Patton to that person who had offered to make alterations in our electricity generating facilities to stop their harm. Governor Patton apparently did not take that action and following subsequent "actions" by some people in Kentucky, my connection to this person was severed so I do not know if other areas of the


US availed themselves of his services or if the solution for the problems caused by these devices was squelched as has happened to so much science knowledge that counters current methods.

IF the solution has been applied to this particular tower, we would have no objection to its being erected though it would not be, in my opinion, esthetically adding to the "neighborhood". I realize that change and progress require us to examine our thoughts and beliefs and make decisions based on the welfare of the whole community. I can live with the appearance of the tower if it will benefit the community without harming it. Our medical costs are already far to high and we should not knowingly allow something that will raise them higher particularly since the "fix" exists that has already been applied or can be applied to the cell phone tower.

However, I DO want assurances from you. I want to be assured that my computer and cordless phone networks will not be negatively impacted by the tower's emissions/transmissions. I want to be assured that the health of the people in the neighborhood will not be impacted negatively.

I have contacted some people to ask them questions about this issue. I will send you a copy of the e-mail with the names eliminated. If they reply, I will send them directly to you. I have requested that they "translate" their "language" into verbiage that those of us not trained in unified field theory/quantum physics and other like fields can understand.
