INTRA-AGENCY MEMORANDUM

RE: Water Service Corporation of Kentucky
Alleged Violation of KRS 278.160

On September 27, 2007, an informal conference was convened in this matter. The names of those persons who participated in the conference are listed on the attached sign-in sheet.

The conference focused on whether Water Service had violated KRS 278.160. Essentially, in Case No. 2005-00325,¹ it came to the Commission's attention that Water Service had been charging certain flat fees for fire protection service. The fees appear to have been removed from Water Service's filed tariffs in August 1992, but were not included in Water Service's filed tariffs when Water Service filed its application in Case No. 2005-00325. The participants were unable to agree upon the manner in which the fees were removed from the filed tariffs.

After discussion, Water Service asked Commission Staff if a settlement offer would be considered. The participants felt that, as a matter of administrative economy, it could be preferable for Water Service to present a settlement offer to the Commission prior to requesting a hearing. Water Service indicated that it would attempt to submit its proposal within approximately 30 days.

The conference was then adjourned.
