Ms. O'Donnell,

By letter dated March 8, 2007, we were notified that our wholesale supplier, Owensboro Municipal Utilities (OMU) will be increasing their rate charged to us from \$ 1.373 per 1,000 gallons to \$ 1.405 per 1,000 gallons effective June 1, 2007. As a result, we are submitting a purchased water adjustment to recover the additional water cost to the West Daviess County Water District. Pages 1 - 3 is the information requested by the Public Service Commission for the rate adjustment. Pages 4 and 5 is the revised tariff sheets which pertain to the rate increase. Exhibit A is the before mentioned letter from OMU. Exhibit B is our calculation of how the increase will affect the rates to our customers. Exhibit C is the newspaper notice notifying our customers of the purchased water adjustment submitted to the Public Service Commission to be included in our local newspaper within the next couple of days. 
The increased water cost is the cost difference between purchases at base (current rate) and purchases at new rate.

6. Purchased water adjustment factor \$.04 per 1,000 gallons

The purchased water adjustment factor is obtained by dividing the increased cost of water by the total gallons sold.

Note: The purchased water adjustment factor is added to each thousand gallons sold. If the minimum usage is 2,000 gallons then the purchased water adjustment factor would be added to the minimum bill twice. Revised tariff sheets must be attached showing the rate to be charged by the utility and the effective date of the increased rates.



EXHIBIT C

WEST DAVIESS COUNTY WATER
DISTRICT RATE ADJUSTMENT
INCREASE

In accordance with 807 KAR 5:068 and KRS 278:015, West Daviess County Water District has applied for approval from the Kentucky Public Service Commission for a rate increase of 4 cents per 1,000 gallons of water effective June 1, 2007. The rate increase reflects the additional cost of water purchased from Owensboro Municipal Utilities. The change in rates will increase the average residential customer's water bill of 5,500 gallons with a ¾" meter from \$18.93 to \$19.15; an increase of 1.16%. The following rates are proposed:

Over 20,000 gallons.....\$ 2.44
Per 1,000 gallons
Sales to other water districts.....\$ 2.13
Per 1,000 gallons
Customer charge by meter size:

1".....\$ 3.73 per month
1 1/2".....\$ 7.46 per month
2".....\$ 14.93 per month


