ORDER

On November 2, 2007, the Attorney General of the Commonwealth of Kentucky ("AG"), by and through his Office of Rate Intervention, filed a motion to intervene in this case which the Commission granted on November 16, 2007. On November 5, 2007, the AG submitted his initial request for information to Gasco. The Commission had already suspended Gasco's application prior to the AG's request for intervention and subsequent information request. In order to better facilitate the gathering of information from Gasco by all the parties, the Commission finds that a procedural schedule is needed.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed in this proceeding.
2. The information requested herein is due on or before December 12, 2007. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and 4 copies to the Commission.

3. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

4. Any party shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

5. For any requests to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

6. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5.02.

7. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
