
On July 14, 2010, Windstream Kentucky East, LLC and Windstream Kentucky West, LLC (collectively, "Windstream") filed the Direct Testimony of Cesar Caballero. Windstream filed an original and ten copies of this document.

On July 15, 2010, you contacted Commission Staff Attorney Tiffany Bowman and notified her that Windstream needed to withdraw the July 14, 2010 testimony filing as Windstream had inadvertently placed un-redacted information into that filing which Windstream believed is confidential in nature. You stated that Windstream would file a new version of Mr. Caballero's testimony which redacted the items Windstream's contends are confidential. You stated that Windstream would also move for confidential treatment of those portions of the re-filed testimony, in accordance with Commission regulation. You stated that the new version of Mr. Caballero's testimony would be filed on July 15, 2010 prior to the close of the Commission's office. You requested that the Commission collect and shred the version of Mr. Caballero's testimony, as filed on July 14, 2010.

In furtherance of Windstream's request, the Commission has collected the original and ten copies of the testimony, as filed on July 14, 2010. Although you requested that the Commission destroy these copies through shredding, the Commission declines to do so. Instead, the Commission shall allow a representative from your law office to return to the Commission's office and collect these filings. Please have your representative come to the Commission's File Room and retrieve these filings **no later than July 27, 2010.**
