O R D E R

The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), has requested that the procedural schedule established for this case by our April 28, 2008 Order be amended. The AG's motion states that he has retained a rate design expert to assist in this case and that the expert needs additional time to review changes Blue Grass Energy Cooperative Corporation ("Blue Grass") proposes to its rate classifications. The AG specifically requests that he be permitted an additional week to file his initial data request and states his belief that all subsequent procedural steps would also have to be moved back by one week.

Based on the motion, and being otherwise sufficiently advised, the Commission finds the AG's request to be reasonable and will permit the due date for his initial data request to be moved back by one week, to May 22, 2008. This change to the existing procedural schedule will necessitate further changes thereto; however, we will not move all other dates back by one week, as the AG suggests. Mindful of the existing schedule and the suspension period which expires October 10, 2008, the Commission will amend the schedule as set forth in Appendix A to this Order.

IT IS THEREFORE ORDERED that:

1. The AG's motion asking that an additional week, from May 15, 2008 to May 22, 2008, be allowed for his initial data request is granted.

2. The procedural schedule established by our April 28, 2008 Order is amended as set forth in Appendix A, which is attached hereto and incorporated herein.
