

On April 4, 2008, South Central Telcom, LLC ("South Central Telcom") filed a formal complaint against Windstream Kentucky East, Inc. ("Windstream") citing concerns regarding Windstream's billing of South Central Telcom and its threats to terminate service in connection with the alleged inaccurate bills. On May 6, 2008, South Central Telcom amended its complaint. Windstream filed its response to the amended complaint on June 2, 2008, pursuant to the Commission's Order to satisfy or answer the allegations.
