ORDER

The city of Danville, Kentucky ("Danville") has requested an informal conference in this matter and additional time to respond to allegations contained in the Commission's Order of May 22, 2008. No objections to the motion have been received. Having considered the motion and being otherwise sufficiently advised, the Commission finds that the request should be granted in part and denied in part.

IT IS THEREFORE ORDERED that:

1. Danville's request for an informal conference in this matter is granted.
2. Danville's request for an additional period of time of not less than 30 days following an informal conference to respond to the Commission's Order of May 22, 2008 is denied.
3. Within 7 days of the date of this Order, Danville shall file with the Commission any additional response to all allegations set forth in the Commission's Order of May 22, 2008. Any allegations that Danville has not expressly admitted in this response shall be deemed to be denied.

4. An informal conference in this matter shall be held on July 23, 2008, at 10:00 a.m., Eastern Daylight Time, in Conference Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

5. Within 7 days of the date of this Order, Danville shall file with the Commission its proposed agenda for the informal conference and include therein all issues that Danville wishes to discuss with Commission Staff and the parties to this proceeding.
