On June 26, 2008, Kentucky Industrial Utility Customers, Inc. ("KIUC") filed a motion to reschedule the August 12, 2008 hearing based on the unavailability of its *witness on that date due to a conflict with a hearing in another state*. KIUC further states that it has contacted counsel for all parties who each indicated no opposition to moving the hearing to August 5, 2008.
