ORDER


The March 25, 2008 Order required Burkesville Gas Company ("Burkesville") to file with the Commission by April 23, 2008, its responses to the requests for information. However, Burkesville's responses were received by the Commission on April 25, 2008. In order to have adequate time to review Burkesville's responses, the Commission, on its own motion, HEREBY ORDERS that:

1. The date for all parties and Commission Staff to submit their supplemental requests for information upon Burkesville shall be revised from May 13, 2008 to May 16, 2008.
2. The date for Burkesville to file its responses to the supplemental requests for information shall be revised from June 3, 2008 to June 6, 2008.

Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
