

Please take notice that Duke Energy Kentucky, Inc. has filed a Notice and Application for New AMRP rates. The new case is styled "In the Matter of an Adjustment of Rider AMRP of Duke Energy Kentucky, Inc." Case No. 2008-00114. The charges for the respective gas service schedules for the revenue month beginning June 2008 is:

Rate RS, Residential Service - \$1.05/month which results in a 0.995% increase

Rate GS, General Service - \$4.54/month which results in a 0.995% increase

Rate DGS, Distributed Generation Service - \$0.00/month which results in a 0.000%

Rate FT-L, Firm Transportation Service- Large - \$0.0068/CCF which results in a 0.984% increase

Rate IT, Interruptible Transportation Service - \$0.0029/CCF which results in a 0.986% increase

Rate SSIT, Spark Spread Interruptible Transportation Rate - \$0.0000/CCF which results in 0.000%

The rates contained in this notice are the rates proposed by Duke Energy Kentucky, Inc. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates in this notice. Any corporation, association, body politic or person may by motion within thirty (30) days after publication of notice of the proposed rate changes request leave to intervene. The motion shall be submitted to the Public Service Commission, 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602, and shall set forth the grounds for the request including the status and interest of the party.
