



Please take notice that Duke Energy Kentucky, Inc. has received approval from the Public Service Commission to bifurcate its DSM case. The new case is styled "In the Matter of The Application of Duke Energy Kentucky, Inc. to Re-Institute a Home Energy Assistance Program" Case No. 2008-00100, the proposed Heat Fund Amount for a typical residential customer is:

Gas - \$0.10/month which results in a 0.070% increase

Electric - \$0.10/month which results in a 0.130% increase

Combination gas & electric - \$0.20/month which results in a 0.091% increase

The rates contained in this notice are the rates proposed by ~~Duke Energy Kentucky, Inc.~~ However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates in this notice. Any corporation, association, body politic or person may by motion within thirty (30) days after publication of notice of the proposed rate changes request leave to intervene.
