

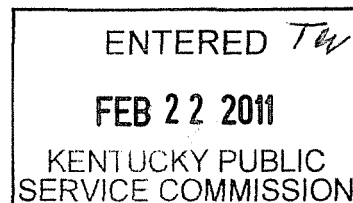
1. The procedural schedule is approved.
