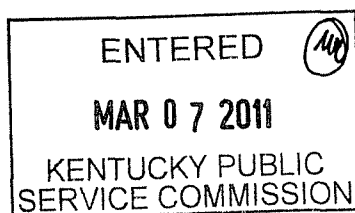
O R D E R

On February 10, 2011, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky and Sprint Spectrum L.P., Nextel West Corp., and NPCR, Inc. d/b/a Nextel Partners and Sprint Communications Company L.P. jointly filed with the Commission a Motion to Withdraw Petition and Close Docket. As grounds for their motion, the parties state that they have reached an agreement to extend their current interconnection agreement to March 1, 2012. On February 26, 2011, the parties filed an executed agreement extending the parties' current interconnection agreement, thus obviating the need for any further proceedings in this case.


Having reviewed the motion and extension agreement, the Commission finds that sufficient grounds exist to dismiss the above captioned cases.
