ORDER

On October 22, 2003, in Case No. 2003-00141,¹ the Commission approved rates for Kentucky Frontier Gas, LLC d/b/a Mike Little Gas Company, Inc. ("Mike Little") and provided for their further adjustment in accordance with Mike Little's Gas Cost Adjustment ("GCA") clause.

On October 1, 2010, Mike Little filed its proposed GCA to be effective November 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Mike Little's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Mike Little's notice sets out an Expected Gas Cost ("EGC") of \$5.4087 per Mcf. Mike Little inadvertently failed to include gas cost from its supplier, Columbia Gas

of Kentucky, Inc., in its calculation. Correcting for this produces an EGC of \$6.5786 per Mcf, which is a decrease of \$.2379 per Mcf from the previous EGC of \$6.8165 per Mcf.

- 3. Mike Little's notice sets out no current quarter Refund Adjustment ("RA") and it had no RAs from previous quarters.
- 4. Mike Little's notice sets out a current quarter Actual Adjustment ("AA") of \$.0897 per Mcf. Mike Little's total AA of \$1.8171 per Mcf is an increase of \$.4571 per Mcf from the previous total AA of \$1.3600 per Mcf.
- 5. Mike Little's GCA rate is \$8.3957 per Mcf, which is an increase of \$.2192 per Mcf from the previous rate of \$8.1765 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Mike Little on and after November 1, 2010.

IT IS THEREFORE ORDERED that:

- 1. Mike Little's proposed rates are denied.
- 2. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after November 1, 2010.
- 3. Within 20 days of the date of this Order, Mike Little shall file its revised tariffs with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
