O R D E R

On November 3, 2010, Judy Water Association (“Judy Water”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Judy Water purchases water from the cities of North Middletown (“North Middletown”) and Mount Sterling.

2. North Middletown notified Judy Water, effective October 31, 2010, that North Middletown’s wholesale water rate to Judy Water would increase from \$3.62 per thousand gallons for the first two million gallons and \$3.72 per thousand gallons for over two million gallons, to \$5.54 per thousand gallons for the first two million gallons and \$5.64 per thousand gallons for over two million gallons.

On October 29, 2010 Judy Water’s Board of Directors authorized an increase in Judy Water’s water rates commensurate with the increase in North Middletown’s rates, effective October 31, 2010.

3. During the 12 months ending October 31, 2010, Judy Water purchased a total of 44,062,000 gallons of water from North Middletown and 109,730,900 gallons from Mount Sterling, and sold 137,979,400 gallons. The increase in the cost of

purchased water is \$84,599.04, resulting in a purchased water adjustment of \$0.62 per 1,000 gallons.

4. The purchased water adjustment of \$0.62 per 1,000 gallons is fair, just, and reasonable and should be approved.

5. Judy Water miscalculated the minimum bill for customers connected to the Bourbon County Water Line Extension who are assessed a surcharge. The minimum bill for these customers should be \$29.31.

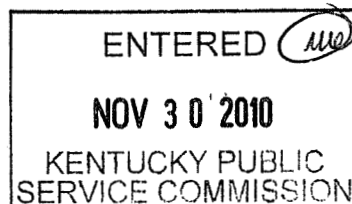
IT IS THEREFORE ORDERED that:

1. The rates proposed by Judy Water are approved.  
2. The purchased water adjustment of \$0.62 per 1,000 gallons as calculated in Appendix A is approved.


3. The rates in Appendix B are approved for water service rendered on or after October 31, 2010.

4. Within 20 days of the date of this Order, Judy Water shall file a revised tariff with the Commission reflecting the rates approved herein.
