ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's Gas Cost Adjustment ("GCA") clause.¹

On December 1, 2010, Belfry filed its GCA to be effective January 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Belfry's notice sets out an Expected Gas Cost ("EGC") of \$5.8029 per Mcf, a decrease of \$.7263 per Mcf from its prior EGC of \$6.5292 per Mcf.
 - 3. Belfry's notice sets out no Refund Adjustment.
- 4. Belfry's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0416) per Mcf. Belfry did not use the \$6.1429 per Mcf "EGC in effect for month" in

calculating the monthly cost differences for July, August, and September 2010. Correcting this produces a current AA of (\$.0226) per Mcf. Belfry's total AA is \$.5159 per Mcf, which is an increase of \$.6848 per Mcf from its previous total AA of (\$.1689) per Mcf.

- 5. Belfry's notice sets out no Balance Adjustment.
- 6. Belfry's GCA is \$6.3188 per Mcf, which is a decrease of \$.0415 per Mcf from its previous rate of \$6.3603 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Belfry on and after January 1, 2011.

IT IS THEREFORE ORDERED that:

- 1. Belfry's proposed rates are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after January 1, 2011.
- 3. Within 20 days of the date of this Order, Belfry shall file with the Commission its revised tariff sheets setting out the rates authorized herein, reflecting that they were approved pursuant to this Order.
