O R D E R

Pursuant to 807 KAR 5:056, the Commission, on January 26, 2011, established this case to review and evaluate the application of the Fuel Adjustment Clause ("FAC") of Kenergy Corp. ("Kenergy") for the period from July 17, 2009 through October 31, 2010.

As part of this review, the Commission ordered Kenergy to submit certain information and an affidavit attesting to its adherence to 807 KAR 5:056. The Commission further ordered that a public hearing be held in this case but cancelled it when, after publication of notice, no interested person advised the Commission of his or her intent to attend.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. During the period under review, Kenergy has complied in all material respects with the provisions of 807 KAR 5:056.

2. Big Rivers Electric Corporation (“Big Rivers”), the wholesale supplier of Kenergy, has been authorized to transfer (roll-in) to its base energy rates 10.212 mills per kWh of fuel costs that were being recovered through its FAC.<sup>1</sup>

3. Except for its direct-served customers, Kenergy should be authorized to transfer (roll-in) to its base energy rates 10.749 mills per kWh to reflect, as adjusted for line loss, the transfer (roll-in) by Big Rivers of 10.212 mills per kWh of fuel costs to Big Rivers’ base energy rates that were being recovered through its FAC. As there is no line adjustment for direct-served customers, Kenergy should be authorized to transfer (roll-in) 10.212 mills per kWh to the base energy rates applicable to its direct-served customers.

4. The rates and charges in the Appendix to this Order are fair, just, and reasonable, and reflect the transfer of fuel costs from the FAC to the base rate.

IT IS THEREFORE ORDERED that:

1. The charges and credits applied by Kenergy through the FAC for the period from July 17, 2009 through October 31, 2010 are approved.

2. Except for its direct-served customers, Kenergy shall transfer (roll-in) 10.749 mills per kWh to base energy rates (as adjusted for line-loss) to reflect the transfer (roll-in) by Big Rivers of 10.212 mills per kWh of fuel costs from its FAC to its base energy rates as approved in Case No. 2010-00495. As there is no line adjustment

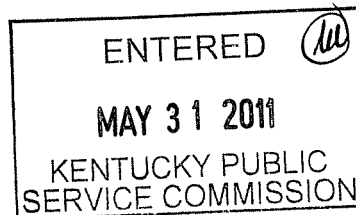

for direct-served customers, Kenergy shall transfer (roll-in) 10.212 mills per kWh to the base energy rates applicable to its direct-served customers.


3. The rates in the Appendix to this Order are approved for service rendered by Kenergy on and after June 1, 2011, the effective date of Big Rivers' change in rates.

4. Within 20 days of the date of this Order, Kenergy shall file revised tariff sheets with the Commission setting out the rates approved herein and reflecting that they were approved by this Order.
