ORDER

On December 28, 2010, Union County Water District ("Union County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Union County purchases water from the city of Morganfield ("Morganfield").
- 2. Morganfield notified Union County that, effective December 31, 2010, Morganfield's wholesale water rate would increase from \$1.3816 per 1,000 gallons to \$1.4980 per 1,000 gallons.
- 3. Union County proposed a purchased water adjustment factor of \$0.13 per 1,000 gallons.
- 4. On December 31, 2010, Union County adjusted its rates for water service commensurate with the increase in Morganfield's wholesale water rate.

- 5. During the 12 months ending October 31, 2010, Union County purchased 307,955,800 gallons of water from Morganfield and sold 282,709,230 gallons. The increase in the cost of purchased water is \$35,846.06, resulting in a purchased water adjustment factor of \$0.13 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$0.13 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Union County's proposed rates are approved.
- 2. The purchased water adjustment factor of \$0.13 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for service rendered on or after December 31, 2010.
- 4. Union County's revised tariff sheets filed with the application are approved.
