

AMENDED PETITION FOR RECONSIDERATION


KENERGY CORP. moves the Pubic Service Commission to reconsider its order of November 17, 2011, on the following grounds:

1. Page 5 of the order adopts Kenergy’s depreciation rates but puts them into effect on the date of the order. Kenergy submits that the depreciation rates should be effective September 1, 2011, per the terms in the settlement.

2. Schedules 34 and 35 on page 5 of the Appendix B to the order contain the wholesale rates on the energy charge for Class B and C industrial customers. However, the retail adder was omitted from this schedule. The correct energy charge rates should be .024671 on Schedule 34 and .027505 on Schedule 35.


3. Kenergy also requests that any relief granted on Petition for Rehearing in the Big Rivers Electric Corporation rate case No. 2011-00036 flow through herein, subject to any response Kenergy files to Big Rivers’ petition for rehearing.
