On August 26, 2011, an informal conference ("IC") was conducted to discuss the August 19, 2011 petition for rehearing submitted by the Joint Applicants in this matter [Duke Energy Corporation ("Duke Energy"), Cinergy Corp, Duke Energy Ohio, Inc., Duke Energy Kentucky, Inc., Diamond Acquisition Corporation, and Progress Energy, Inc.] The IC was attended by representatives of Joint Applicants, the Attorney General of the Commonwealth of Kentucky ("AG") and Commission Staff ("Staff"). A copy of the attendance list for the IC is attached hereto.

Joint Applicants had requested an IC for the purpose of providing clarification of their rehearing petition, which relates to the Commission's August 2, 2011 order that required Duke Energy's post-merger Board of Directors to include at least one non-employee member who is a customer of one of its Midwest utilities. Joint Applicants used the IC to expand on their concerns regarding their ability to comply with this requirement. They also responded to questions and comments from the AG and Staff.

Staff indicated that it anticipated that the Commission would grant the request for rehearing due to the nature of the concerns raised therein. Staff also indicated that another IC would possibly be scheduled once it had received guidance from the Commission on how it, the Staff, should proceed in this matter.

With that understanding, the IC was adjourned.
