O R D E R

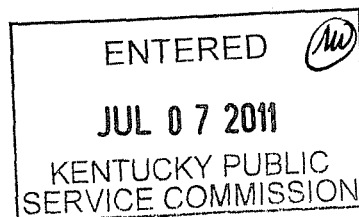
This matter is before the Commission upon a motion filed by Owen Electric Cooperative Corporation ("Owen") requesting an extension of time in which to file its responses to the Commission Staff's First Information Request and the Attorney General's Initial Data Requests. Pursuant to the Commission's Scheduling Order of June 10, 2011, Owen's response to initial information requests is due on or before July 8, 2011. In support of its motion for extension, Owen states that it will not be able to complete its responses to the initial information requests due to several key staff members being on vacation the first two weeks of July. Owen requests an extension until July 22, 2011 in which to file its discovery responses.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that good cause exists to grant Owen's motion and that the procedural schedule set forth in the Commission's Order of June 10, 2011 should be revised.

IT IS THEREFORE ORDRED that:

1. Owen's motion for an extension of time is granted.
2. The procedural schedule established pursuant to the Commission's June 10, 2011 Order is superseded and replaced by the procedural schedule set forth in the Appendix to this Order.
