Senior Citizen Farmers Market Vouchers

Wolfe County has been awarded Senior Citizen Farmers Market Nutrition Program Vouchers again for this 2011 growing season to be used at the Wolfe County Farmers Market. Each eligible Senior Citizen that applies for this Program will receive a book of checks (each check is worth \$4.00 dollars) with a total of \$28.00 dollars per person. This is the fourth year that Wolfe County has been awarded these vouchers from the Kentucky Department of Agriculture.

Program Eligibility Guidelines

1. Must be 60 years of age.
2. Must fit into the income guidelines shown below.
3. Must fill out Senior FMNP Application.
4. Must provide proof of age and income.
5. Sign up period begins June 13th, 2011.
6. If you receive food commodities already then you do not need to bring in your proof of age and income.
