ORDER

On June 9, 2011, Madison County Utilities District ("Madison County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Madison County purchases water from Richmond Utilities ("Richmond").
- 2. Richmond notified Madison County that, effective July 1, 2011, its volumetric wholesale rate to Madison County will increase from \$2.14 per 100 cubic feet to \$2.17 per 100 cubic feet.
- 3. Madison County proposes a purchased water adjustment factor of \$0.03 per 100 cubic feet.
- 4. During the 12 months ending April 30, 2011, Madison County purchased 88,647,400 cubic feet of water from Richmond and it sold 78,838,824 cubic feet. The increase in the cost of purchased water is \$26,594.22, resulting in a purchased water adjustment factor of \$0.03 per 100 cubic feet.

- 5. Madison County incorrectly applied the purchased water adjustment of \$0.03 per 100 cubic feet to its current rates. The rates proposed by Madison County should be denied.
- 6. The purchased water adjustment factor of \$0.03 per 100 cubic feet is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Madison County's proposed rates are denied.
- 2. The purchased water adjustment factor of \$0.03 per 100 cubic feet as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for services rendered on or after July 1, 2011.
- 4. Within 20 days of the date of this Order, Madison County shall file new tariff sheets showing the rates approved herein.
