





NOTICE TO THE CUSTOMERS OF CANNONSBURG WATER DISTRICT

On August 8, 2011, Cannonsburg Water District applied to the Kentucky Public Service Commission ("PSC") for authority to adjust its rates for water service. It subsequently requested that the PSC authorize the assessment of the surcharge to permit the water district to fund its efforts to reduce its non-revenue water. After performing a review of Cannonsburg Water District's application and records, the PSC Staff has recommended to the PSC that Cannonsburg Water District be granted an increase greater than that requested and further be authorized to access a monthly surcharge of \$5.53 for three years. The proceeds of this surcharge would be used solely to fund Cannonsburg Water District's efforts to reduce its non-revenue water. Pursuant to the PSC's Order of February 27, 2012, Cannonsburg Water District has requested that the PSC approve the higher rates and the recommended surcharge. Any corporation, association, body politic or person may submit comments on the proposed request no later than March 9, 2012. Comments shall be in writing and shall be submitted to the Executive Director, Public Service Commission, 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky, 40602.
