#### ORDER

On October 31, 2011, Louisville Gas and Electric Company ("LG&E") submitted tariffs to cancel and withdraw its Residential Responsive Pricing Service tariff and the General Responsive Pricing Service tariff, effective January 1, 2012. Finding that additional inquiry was necessary, the Commission suspended the tariffs on November 14, 2011, established this proceeding, and stated that a procedural schedule would be established at a later date. This Order establishes that schedule.

The Commission further finds that this Order should be served on the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention ("AG"), and the Kentucky Industrial Utility Customers, Inc. ("KIUC"), both of whom intervened in Case No. 2007-00117<sup>1</sup> wherein LG&E was authorized to establish the subject tariffs.

#### IT IS THEREFORE ORDERED that:

 The procedural schedule set forth in the appendix to this Order shall be followed in this proceeding.
