ORDER

On October 31, 2008, in Case No. 2008-00032, the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a monthly basis in accordance with Burkeville's Gas Cost Adjustment ("GCA") clause.

On December 1, 2011, Burkesville filed its proposed GCA to be effective January 1, 2012.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Burkesville's proposed Expected Gas Cost ("EGC") is \$8.3512 per Mcf, which is an increase of \$.1472 per Mcf from the prior EGC of \$8.2040 per Mcf.
 - 3. Burkesville's notice sets out no Refund Adjustment.

- 4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$.0583) per Mcf. Burkesville's total AA of (\$.9714) per Mcf represents a decrease of \$.0148 per Mcf from the previous total AA of (\$.9566) per Mcf.
- 5. Burkesville's GCA is \$7.3798 per Mcf, which is an increase of \$.1324 per Mcf from the previous GCA of \$7.2474 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Burkesville on and after January 1, 2012.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after January 1, 2012.
- 2. Within 20 days of the date of this Order, Burkesville shall file its revised tariffs with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
