ORDER

This matter arises upon the motion of Lexington-Fayette Urban County Government ("LFUCG") for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission notes that LFUCG, in its motion, has waived its right to service of Commission orders by United States mail, designated its agents to receive electronic transmission of documents and pleadings, and acknowledged that its agents possess the facilities to receive electronic transmissions.

The Commission, being otherwise sufficiently advised, finds that LFUCG should be granted full rights of a party in this proceeding and should accept the procedural schedule as it now stands.


IT IS HEREBY ORDERED that:

2. LFUCG shall accept the existing procedural schedule.


