ORDER

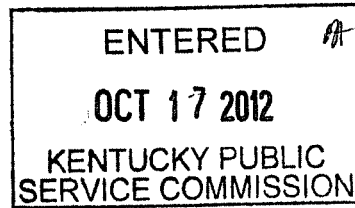
This matter arises upon the motion of the Community Action Council for Lexington-Fayette, Bourbon, Harrison and Nicholas Counties, Inc. ("CAC") for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that a procedural schedule was established in this proceeding by Order dated October 1, 2012, Appendix B. The Commission, being otherwise sufficiently advised, finds that CAC should be granted full rights of a party in this proceeding and should accept the procedural schedule as it now stands.

IT IS HEREBY ORDERED that:


1. The motion of CAC to intervene is granted, and CAC shall accept the existing procedural schedule.
2. CAC shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should CAC file documents of any kind with the Commission in the course of these proceedings, CAC shall also serve a copy of said documents on all other parties of record.
